# Greater Fox Cities USBC Open Championship Rules

**Eligibility:** Tournament is open to current 2025-2026 sanctioned Greater Fox Cities USBC members, 18 years or older, with at least 21 games in any Greater Fox Cities USBC sanctioned league. Bowlers with less than 21 games, in one league, can apply for a special exemption by sending an e-mail to: [gfcba920@gmail.com](mailto:gfcba920@gmail.com)

**Averages:** Bowlers will use last season's highest average as listed on Bowl.com. If their current average of 21 or more games, at the time of bowling, is 15 or more pins higher, then they shall use the higher average. It is the bowler's responsibility to verify their average. Failure to use proper average, or to make correction prior to the time of bowling, will disqualify their score. The Tournament Committee reserves the right to adjust any bowler's starting average. If no average, the bowler will bowl scratch.

If a bowler has a Challenge or Sport League Average only, their average will be adjusted per the applicable USBC Rerating Chart. If the bowler possesses both a Challenge or Sport and a House Average, the House Average will be used. If the Challenge Average is greater than the House Average, then it will be used and not adjusted.

**Dress Code:** Entrants are required to wear proper bowling attire. Prohibited articles of clothing include, but not limited to, sleeveless shirts, tank tops, halter tops, short shorts/short skirts, offensive language and pictures, drug paraphernalia.

Rule 1 Handicap will be 90% of 230.

Rule 2 There will be (1) one division for all portions of the tournament. Handicap will be based on 920 for team, 460 for doubles, and 230 for singles

Rule 3 An entrant may bowl as many times as they want in the team event, however, they may only bowl once in doubles & singles.

Rule 4 No more than (3) three bowlers shall cash together more than once in the team event.

Rule 5 All-Events: The first attempt for the team event will count toward All-Events score.

Rule 6 Prize fee will be returned 100% based on ratio 1:5 in each event.

Rule 7 All other USBC tournament rules apply. The Tournament Committee reserves the right to handle all disputes. Their decision is final.

Rule 8 Advanced registration, with payment is required. No Walk-ins!

Rule 9 Dates will be honored on a first come, first served basis.

**THE TOURNAMENT DIRECTOR AND COMMITTEE RESERVES THE RIGHT TO DECIDE ANY OTHER MATTERS PERTAINING TO THE OPERATION OF THE TOURNAMENT NOT COVERED BY THE RULES ABOVE.**
